Painters Union Fringe Benefit Funds Privacy Policy

Thank you for visiting the Painters Union Fringe Benefit Funds (Painters Union Pension Fund, Painters Union Insurance Fund, Painters Union Vacation Fund, (Finishing Trades Institute of the Great Lakes) (collectively, the “Funds”) website and reviewing our privacy statement. Our privacy policy is clear: The Funds do not collect any personal identifiable information without your consent. Here is how the Funds handle your information when you visit the Funds website:

Cookies

When you visit some websites, their web servers generate pieces of information known as cookies. A “cookie” is a small summary text file that is stored by your mobile phone (e.g., iPhone or Android) or by your browser (e.g., Internet Explorer, Edge, Chrome, Safari or Firefox). Cookies allow a website to store some information about users, allowing the website to recognize a user and respond appropriately.

- The website may use cookies to collect anonymous usage statistics to track site utilization. Identifiable visitor usage information may also be stored in internal log files. We use this information to troubleshoot issues, improve our online services, and for analytical purposes, such as analyzing trends, administering the Site, tracking user movements and gathering broad demographic information.
- The website utilizes cookies to ensure basic functionality for authenticated users, including but not limited to initiating and terminating valid sessions.

You Send Us Personal Information

If you choose to provide the Funds with personal information, through the website or email, the Funds may use that information to respond to your message. This also helps the Funds to locate the information you may have requested or move forward with Fund business. The Funds treat emails the same way that they handle paper-based correspondence. The Funds are required to maintain many documents under ERISA and the Internal Revenue Code, but they do not collect personal information for any purpose other than for Fund business. The Funds only share the information you provide for Fund business purposes, as authorized by you or as otherwise required by law. The Funds do not collect information for commercial marketing.

Please read the Privacy Statement of each website you visit. The Funds’ website may have links to other websites. Once you access another site through a link that the Funds provide, you are subject to the Privacy Statement of the other organization's site.

Website Security

This website is hosted on a server at a secure facility and it is encrypted to protect data. The server runs active anti-virus programs; firewalls run gateway-level intrusion prevention. All transactions on this website are via HTTPS. This website requires username and password authentication using credentials assigned by the Fund Office.
